Spectrum Eye Care uses advance diagnostic testing not covered by OHIP to detect and manage eye disease earlier and more precisely, resulting in better health outcomes. These tests do <u>not</u> replace traditional examination measures but they allow us to vastly minimize the amount of face to face examination time behind the microscope.

The Optomap ultra-widefield retinal image is a unique technology that captures more than 80% of your retina in one panoramic image. The unique ultra-widefield view helps the Optometrist detect early signs of retinal holes, tears and detachments more effectively and efficiently. In addition it serves as a baseline for comparison to evaluate for Macular Degeneration, Glaucoma and changes secondary to Diabetes and High Blood Pressure.
